I understand that my membership is non-refundable and non-transferrable regardless of the circumstances, medical or otherwise. Golf management reserves the right to open or close the course at any time or stop play and ask players to leave the course immediately due to rain or lightning or any other reason deemed by management.

I understand that there are certain risks involved in using the club facilities, golf carts and equipment, which include the risks of serious personal injuries resulting from being struck by a golf ball or hit by thrown objects or any other incidents during golf activities, including negligent actions or misconduct of third parties or because of negligence (including gross negligence), of the club, its agents and employees. I hereby release, on behalf of myself, my heirs, administrators and assigns, Great Cove Golf & Recreation Club, its owners, managers, officers, employees, and agents from all liability of any kind which may result from my use of the club facilities.

Injury Clause: If by chance a member sustains an injury, during the current year membership, that will not allow such member to play golf for an extended period of time, such member may petition the GC Board to have up to 50% of their current year's dues deferred and credited to their next year membership. If the injury occurs after June 30th of the current membership year or the member has already played 30 rounds of golf, then the deferment would be denied.
